

ORDINANCE NO. 3-20-95

AN ORDINANCE PROVIDING FOR A PERMIT TO MOVE A MOBILE HOME, HOUSE TRAILER OR MANUFACTURED HOUSING ON OR UPON THE STREETS, AVENUES OR PUBLIC WAYS WITHIN THE TOWN OF NEWTON.

WHEREAS, the Town Council of the Town of Newton (hereinafter referred to as the "Council"), recognizes the importance of monitoring the movement of mobile homes, house trailers, and/or manufactured housing within the town limits; and,

WHEREAS, to provide for the health, safety and welfare of the citizens of the Town of Newton, the Council desires to create a monitoring system to track the movement of mobile homes, house trailers and/or manufactured housing within the town limits;

NOW THEREFORE, BE IT ORDAINED by the Council in regular session sitting as follows:

Section One - Permit Required. Prior to any movement of a mobile home, house trailer, or manufactured housing over or upon the streets, avenues and public ways within the Town of Newton, a permit shall be obtained by the person, firm or corporation desiring to move such mobile home, house trailer or manufactured housing.

Section Two - Permit Application. The permit described in Paragraph 1 above shall be obtained at the office of the Town Clerk at Town Hall in Newton. The application for such permit shall contain the name, address and telephone number of the applicant, the owner, and the person or company moving such mobile home, house trailer or manufactured housing, and shall describe by size, weight and identification number the mobile home, house trailer or manufactured housing to be moved. The applicant shall identify the route proposed to be traveled within the Town of Newton and the final destination, if within the Town of Newton.

Section Three - Permit Fee. There shall be no charge for the issuance of such permit.

Section Four - Clerk Authorized Not to Issue Permit. The Town Clerk shall not issue a permit for the movement within the Town of Newton if the final destination of such mobile home, house trailer or manufactured housing is located within the Town of Newton and is not in accordance with zoning or planning ordinances of the Town of Newton.

Section Five - Failure to Obtain Permit. Failure to obtain a permit prior to movement of any mobile home, house trailer or manufactured housing within the Town of Newton shall be punishable in Newton Municipal Court with a fine not exceeding Five Hundred Dollars (\$500.00).

Section Six - Effective Date. This ordinance shall become effective within the time provided by statute after the same has been duly approved and published as required by law.
